

"I'd say it's just profit taking and re-assessing," said Manish Singh, chief investment officer at Crossbridge Capital. "The risk is still to the upside as economies keep re-opening more and more. Remember the fiscal and monetary support will stay long after things have opened up. We might see a lull over summer months but Q3/Q4 is looking bright."
